- November 15, 2023 – Priority Decision Application Deadline
- January 15, 2024 – Priority Decision Application Deadline
- February 20, 2024 – Priority Decision Application Deadline
- March 20, 2024 – Application Deadline
- May 15, 2024 – Application Deadline
- June 30, 2024 – Application Deadline
- July 31, 2024 – Final Application Deadline

Regent University School of Law | JD & JD Honors Program Application Process

All admission materials should be submitted using the Law School Admission Council (LSAC) service. Note: All items submitted as part of the law school application process become the property of Regent University and cannot be returned.

- 1. Complete your application** through the Law School Admission Council (LSAC).
- 2. Submit an official transcript** from all institutions you have attended.
- 3. Submit your LSAT scores.** See testing dates and fees below.
- 4. Submit your letter(s) of recommendation.**
- 5. Submit your personal statement** (500 – 1,000 words).

Testing Dates

You must take the Law School Admission Test (LSAT) and subscribe to the Credential Assembly Service (CAS).

- January 12-13, 2024 (register by November 30, 2023)*
- February 9, 2024 (register by December 26, 2023)*
- April 12, 2024 (register by February 29, 2024)*
- June 7-8, 2024 (register by April 23, 2024)*

*Each administration's registration deadline is also the last day to request disability-related testing accommodations, assistive technology, a free Test Date Change, and/or a full refund.

LSAT (includes Writing) - \$222 | Credential Assembly Service (CAS) - \$200 | Law School CAS Report - \$45

Auxiliary Fees

Score Preview - \$45 to \$75

Score Report - \$50

Score Audit - \$150 (\$75 if pre-approved for fee waiver)

Test Date Change - \$135 to \$222
